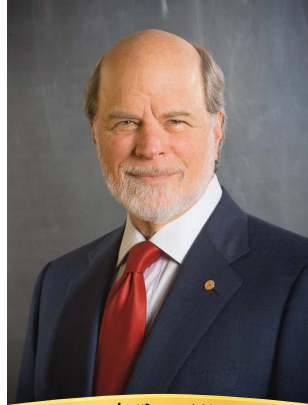

"If a U.S. citizen is arrested in another country, most people don't have a clue whom to call. I know the best lawyers; I fly there; I meet with the lawyers and the client, and I coordinate the entire defense through resolution of the case."

### **DOGGED DEFENSE – WITHOUT THE DRAMA**

Mr. Weiner believes that to assume a "pit bull" stance – charging angrily forward, attacking opposing counsel and going public with case details – is almost always counterproductive and not in the best interests of the client.

"This kind of provocative approach works against the client's interests. It puts them in the spotlight, causing enormous disruption and stress. It alienates judges and other attorneys. We really care about our clients, and are dedicated to getting matters resolved as quickly, quietly and as favorably as possible. This is what we do."
